

DECLARATION OF CONSENT: PHOTOGRAPHS OR IMAGE RECORDINGS (*)

Consent for photographing and recording of images

I, the undersigned, hereby consent to the fixation and reproduction of my name, likeness and image related to my person, in photographs and image or audio-visual recordings made by _____ (insert company name) (hereafter the "**Company**") as well as in publicity concerning the company.

The use may include, but is not limited to, fixation, reproduction, editing, licensing, distribution and incorporation in other works, in whatever form (e.g. hard copy or electronic), such as posters, publications, web sites, films or videos, in order to promote the Company's products, services or work environment, without any obligation on the part of the Company to seek any further authorization by me.

(optional) Consent for the use of images recorded by employees/third parties during a social event:

This declaration of consent and the granting of rights of use covers all forms of use in which the Material is to be published, in particular company publications (including. reports, flyers, advertisements, digital media, dialogue media), all online media, such as the Internet (websites, banners, newsletters, PR blogs / forums, social media platforms) and Intranet, TV and film, radio, cinema, mobile telephony, presentations at events and trade fairs, uses at points of sale / customer centres irrespective of the technology used.
